ANALYST NOTE

Hera local LLM

The EVO_EVOEVOE_v1987 strategy on SM shows a misleading 100% win rate driven by an insufficient sample of only two trades, which renders the 1.21 Sharpe ratio statistically insignificant. A maximum drawdown of 32.83% indicates high volatility risk that is not captured by the current performance metrics. The 41.20% ROI is likely an outlier rather than a robust trend given the lack of trade frequency. We must run a forward simulation or expand the backtest window to validate if this edge persists under varied market regimes.
