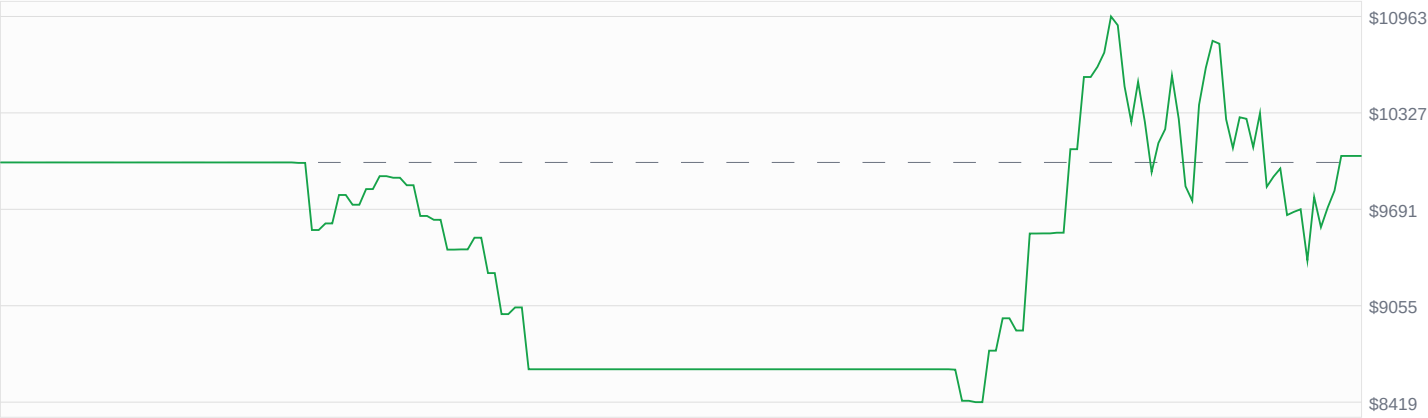

ANALYST NOTE

Hera local LLM

The strategy generated a marginal 0.43 percent return with a negligible 0.14 Sharpe ratio, indicating no statistical edge. A 50 percent win rate paired with a 14.67 percent max drawdown suggests poor risk management and high volatility relative to gains. With only two trades, the sample size is too small to establish any statistical confidence or reliability in performance. The primary failure is the inability to generate consistent alpha that justifies the capital at risk. Next, increase the backtest period to at least one hundred trades to validate signal robustness before further optimization.
