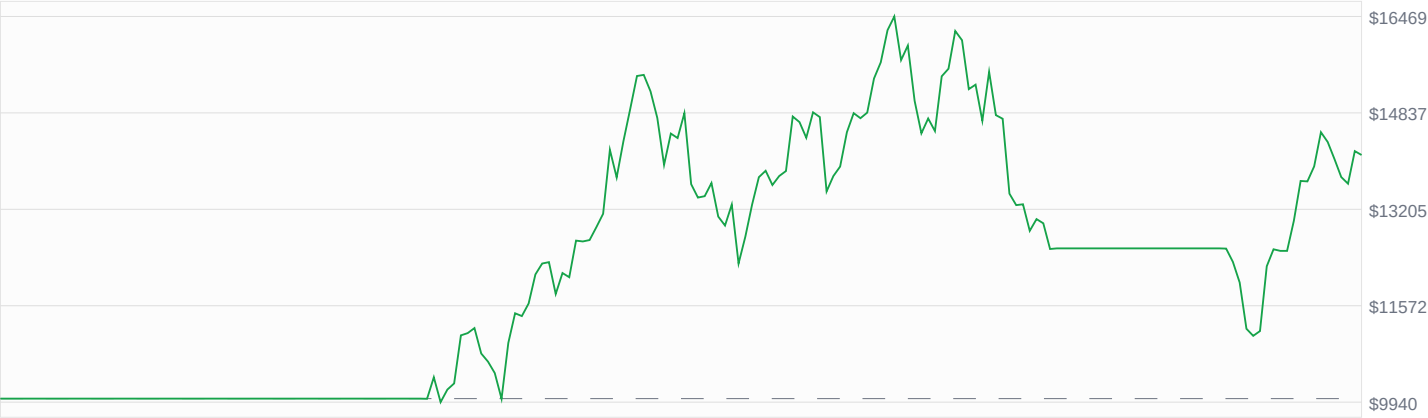

ANALYST NOTE

Hera local LLM

The 100% win rate on SM is statistically meaningless due to the tiny sample of only two trades, which masks the high risk. A max drawdown of 32.83% reveals severe volatility that a Sharpe ratio of 1.21 fails to fully capture in this short window. The +41.20% ROI is likely an artifact of lucky timing rather than robust strategy performance. We need to run a longer backtest across multiple market regimes to validate if the edge persists. This data only suggests the strategy needs tighter risk controls before any live capital is considered.
