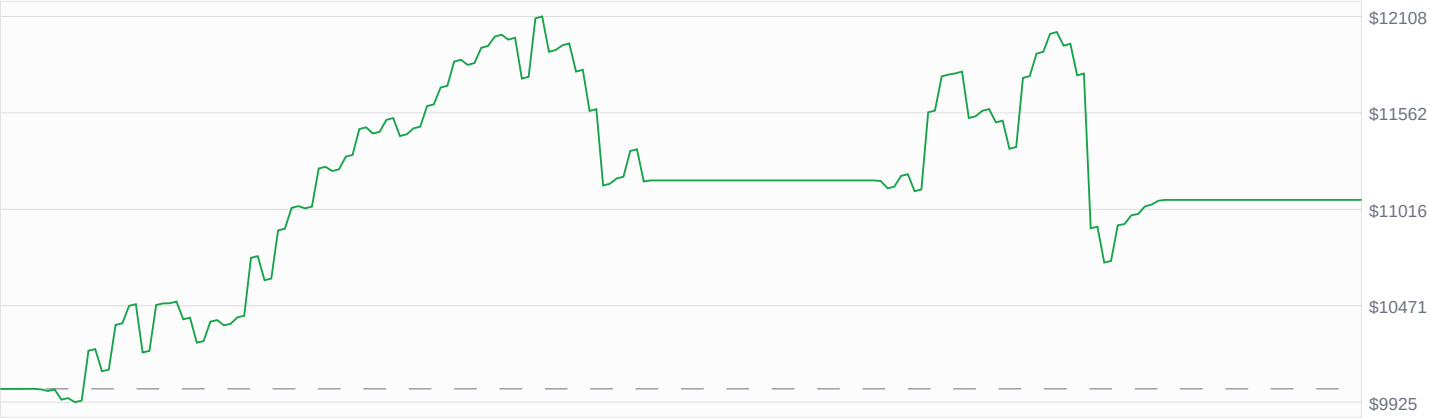

The EVO_EVOEVOEVOE_v2008 strategy on AAPL generated a +10.70% return with a 50% win rate, yet the statistical significance is negligible due to only two completed trades. A Sharpe ratio of 0.87 and 11.50% maximum drawdown suggest moderate risk-adjusted performance but lack robustness from such a sparse sample size. The results indicate potential instability rather than a confirmed edge, as outlier performance cannot be validated without more data points. We must expand the testing window or adjust parameters to generate sufficient trade history before deploying live capital.
