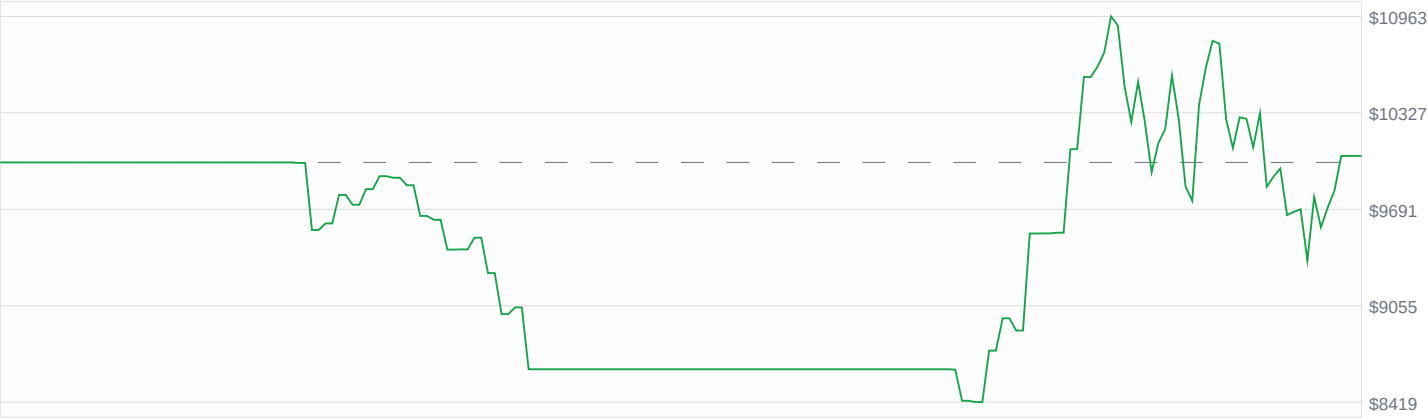

ANALYST NOTE

Hera local LLM

The strategy generated a marginal 0.43% ROI with a 50% win rate, but the 14.67% max drawdown significantly erodes capital efficiency. A Sharpe ratio of 0.14 indicates returns barely exceed the risk-free rate, suggesting poor risk-adjusted performance. Statistical confidence is negligible with only two total trades, making current metrics too noisy for reliable inference. The high drawdown relative to minimal gains implies the entry logic lacks sufficient protection against adverse price moves. Next, increase the sample size to at least fifty trades to validate whether the signal possesses genuine predictive power.
