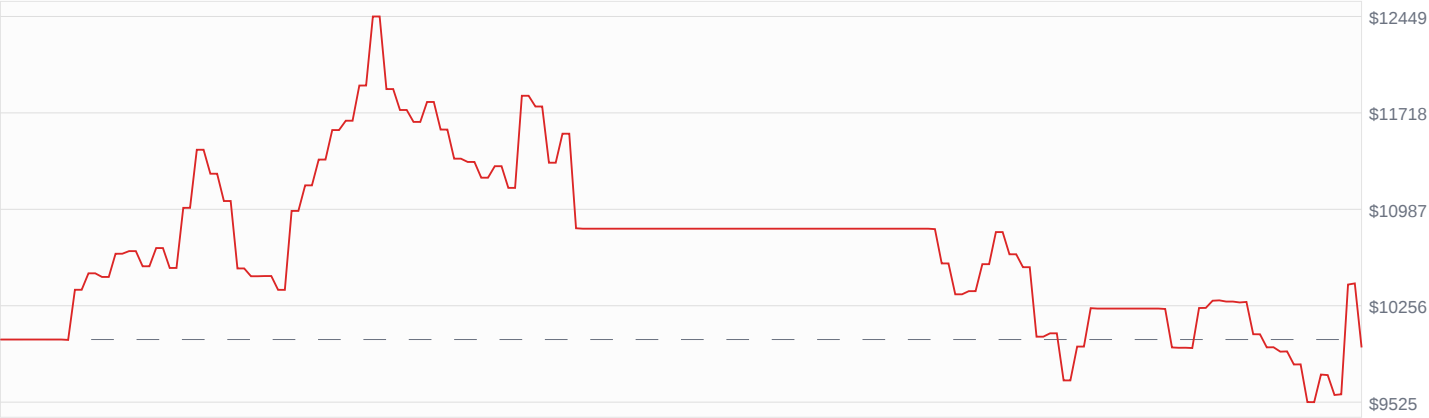

ANALYST NOTE

Hera local LLM

The EVO_GG1RSISNIP_v1558 strategy on NVDA is statistically unreliable due to a sample size of only three trades, rendering the -0.63% ROI and 0.09 Sharpe ratio meaningless confidence intervals. A maximum drawdown of 23.49% indicates significant downside risk, while the 33.3% win rate suggests the entry logic fails to capture sufficient momentum. With such low trade frequency, minor slippage or a single outlier execution price could completely invalidate the performance metrics. The next step is to retrain the model with stricter volatility filters or increase the lookback period to generate a statistically significant sample for validation.
