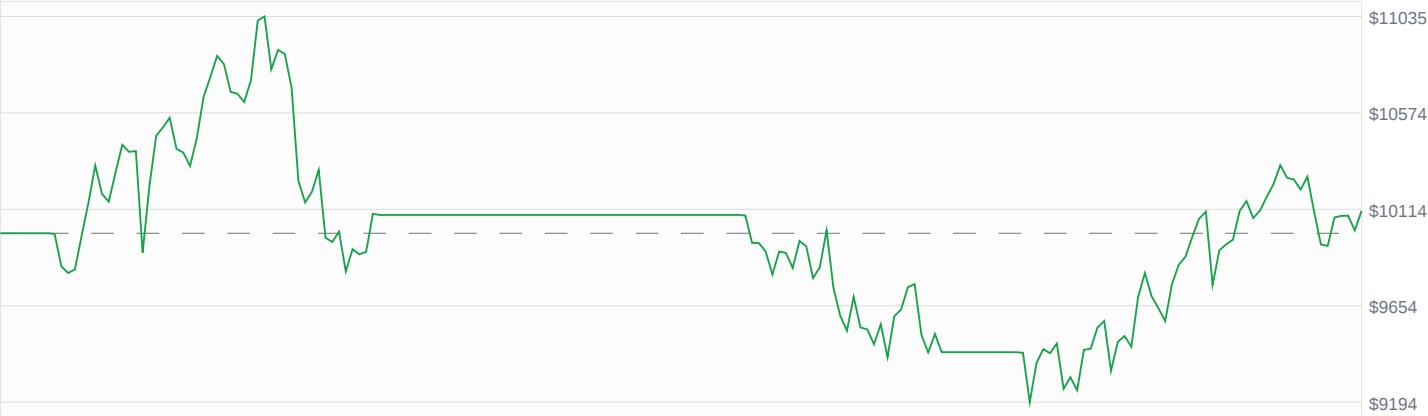

The strategy generated a modest 1.04% return with a 66.7% win rate, but the 0.16 Sharpe ratio indicates negligible risk-adjusted performance. The 16.68% max drawdown is excessive relative to the gains, suggesting poor risk management during losing streaks. With only three total trades, the sample size is statistically insignificant, making it impossible to confirm if results are skill or luck. The primary failure is the lack of capital preservation relative to volatility exposure. The next step is to extend the backtest period to at least fifty trades to establish statistical confidence before further optimization.
