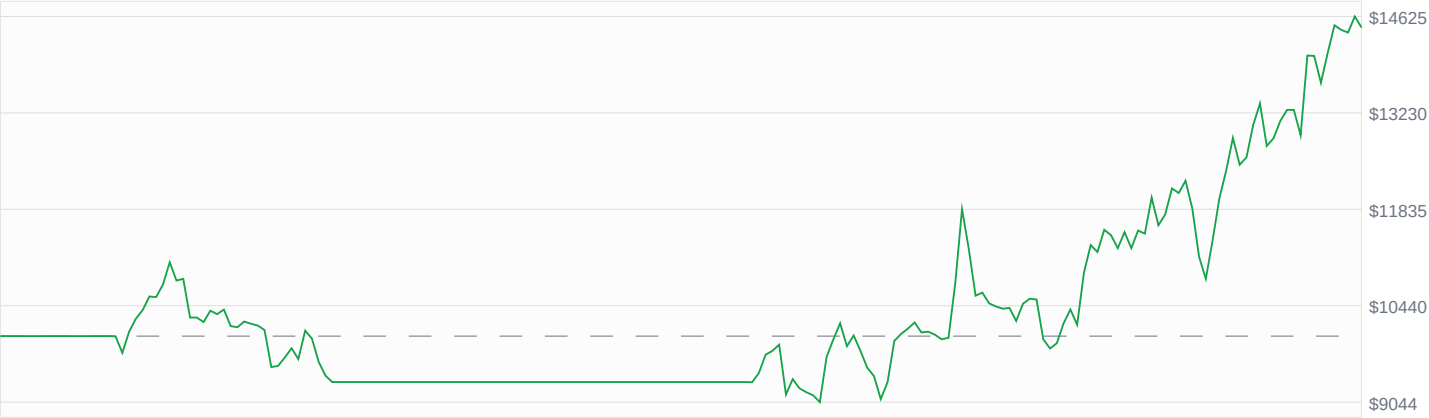

ANALYST NOTE

Hera local LLM

The +44.60% ROI and 1.43 Sharpe ratio appear attractive but are statistically meaningless with only two trades, offering zero confidence in the strategy's true edge. A 50.0% win rate paired with a 13.83% max drawdown suggests high variance that the tiny sample size fails to contextualize or mitigate. The Bollinger Squeeze logic may be capturing momentum, but two data points cannot validate risk-adjusted performance or consistency. The only viable next step is to extend the backtest over a significantly longer historical window to generate a robust sample size before any further evaluation.
