The 100 percent win rate and 21.92 percent return are statistically meaningless with only two trades, so the 1.55 Sharpe ratio is unreliable. The low 5.37 percent drawdown suggests tight risk controls, but sample size precludes any confidence in strategy robustness. This is a data artifact, not evidence of edge. You need at least 30 to 50 trades to evaluate true performance.
