Hera local LLM

The strategy suffered a negative return of 11.23% with a Sharpe ratio of -0.69, indicating poor risk-adjusted performance. A 25.0% win rate alongside a 24.12% maximum drawdown suggests the entry logic fails to capture favorable risk-reward asymmetry. With only four total trades, the sample size is too small to establish statistical confidence or validate the model. The low trade frequency likely stems from overly restrictive signal filters that miss valid market opportunities. Next, relax the entry thresholds to increase sample size and re-evaluate the signal efficacy.
