Hera local LLM

The strategy failed to generate alpha, posting a negative nine percent return and a poor Sharpe ratio. With only three trades, the statistical confidence is negligible, making the results indistinguishable from random noise. The high drawdown relative to the low win rate indicates poor risk management. Next step: increase the sample size to at least fifty trades before evaluating signal validity.
