ANALYST NOTE

Hera local LLM

The strategy yielded a negative return of -0.63% with a negligible Sharpe ratio of 0.09, indicating no statistical edge. A 33.3% win rate paired with a severe 23.49% max drawdown highlights poor risk management and high volatility. With only three trades, the sample size is too small to establish any statistical confidence in the model's performance. The primary failure is the inability to preserve capital during adverse market moves. The immediate next step is to conduct a robust out-of-sample validation with at least fifty trades before considering any live deployment.
