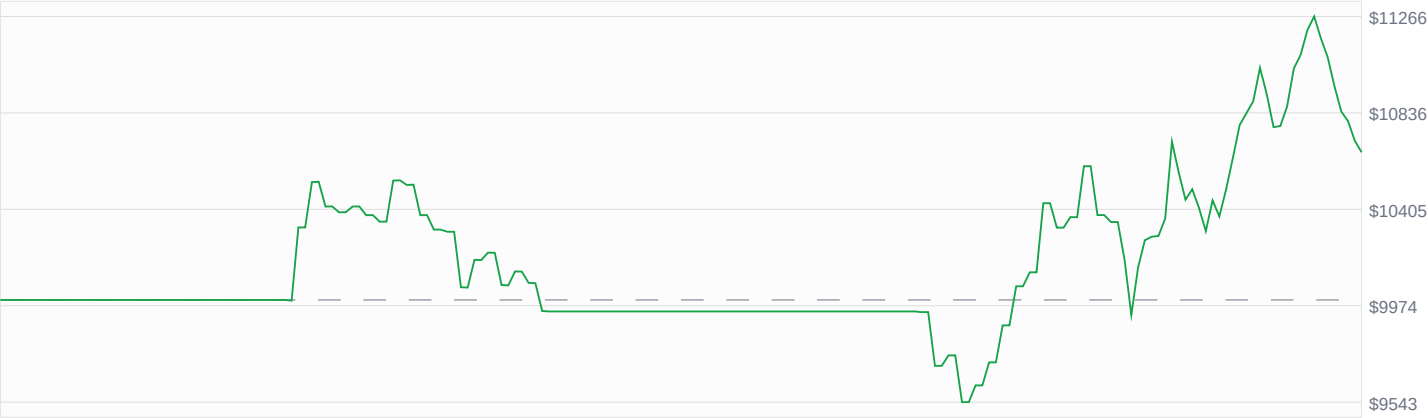

The +6.57% return on SBCF is statistically meaningless due to the tiny sample of two trades, rendering the 0.70 Sharpe ratio unreliable. With a 50% win rate and 8.80% drawdown, the strategy lacks robustness and fails to demonstrate consistent edge or risk control. The mean reversion logic shows no clear statistical significance, making current performance a product of chance rather than skill. You should expand the backtest period to at least fifty trades before considering any deployment.
