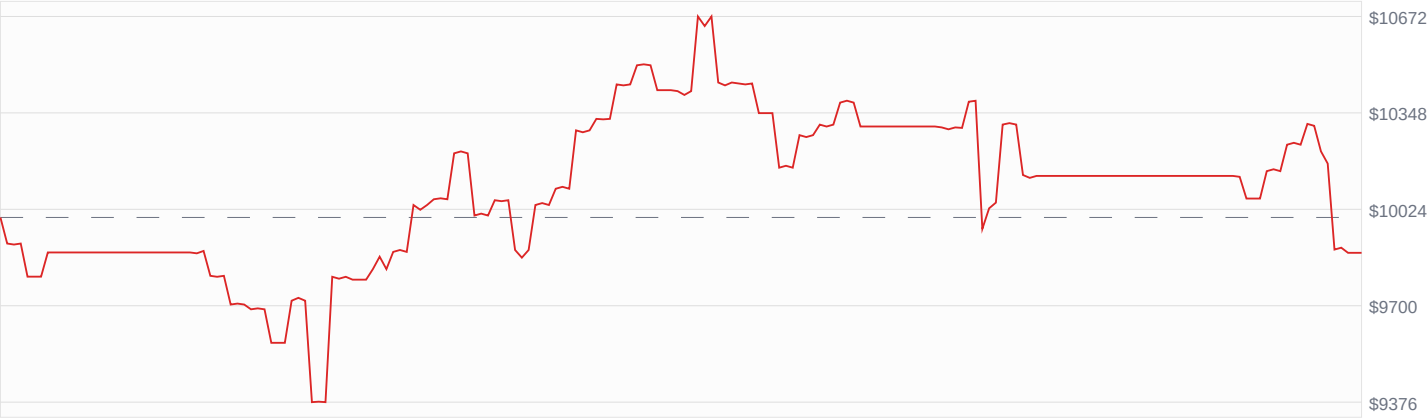

ANALYST NOTE

Hera local LLM

The strategy generated a negative return of -1.22% with a Sharpe ratio of -0.06, indicating poor risk-adjusted performance. A 25% win rate over only four trades is statistically insignificant, meaning the results lack the sample size needed to validate the mean reversion logic. The 7.44% drawdown further highlights the inefficiency of the current signal parameters. Next, extend the backtesting period to at least one hundred trades to establish statistical confidence before deploying capital.
