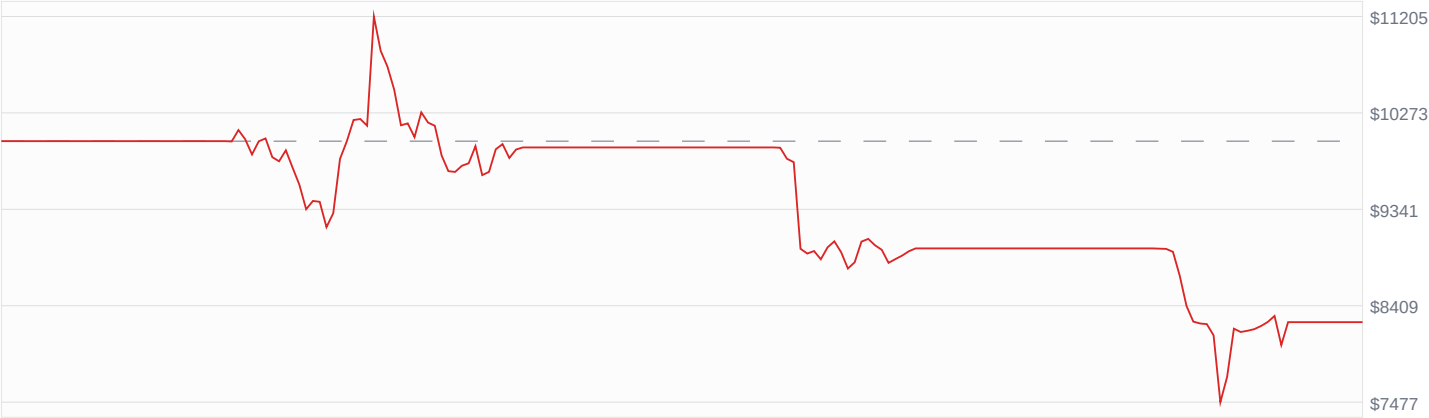

Hera local LLM

The EVO_GG1RSISNIP_v212 strategy failed catastrophically on META with a -17.50% return and zero wins across only three trades. A severe 33.28% drawdown and negative Sharpe ratio indicate the signal logic lacked robustness against this asset's volatility. Such a tiny sample size of three executions offers no statistical confidence to validate or refine the approach. Next, expand the test on a different interval or reduce position sizing to assess resilience before redeployment.
