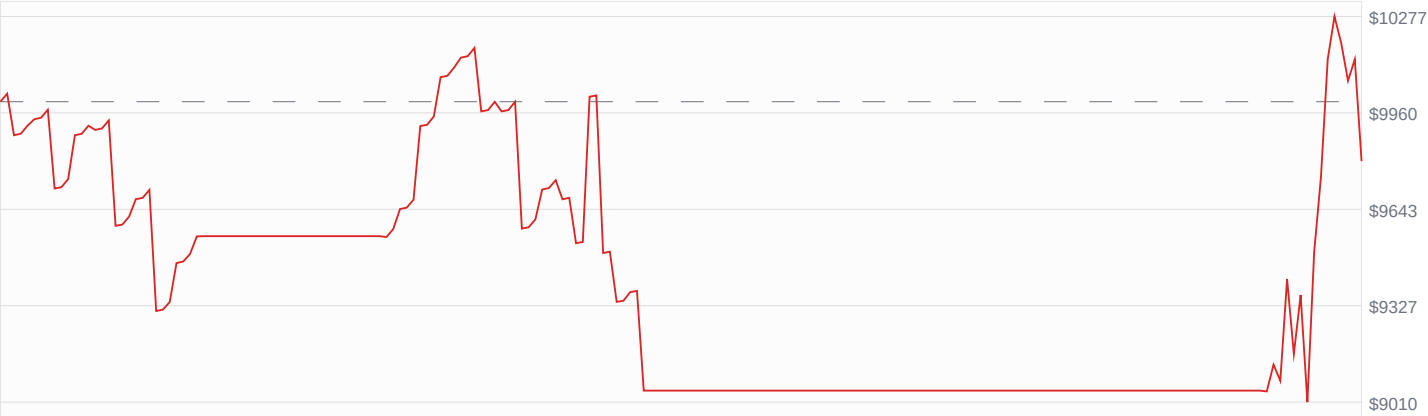

The EVO_GG1RSISNIP_v137 strategy on VOXR underperformed significantly, delivering a -2.01% ROI with a negative Sharpe ratio of -0.05, indicating a net loss relative to risk-free alternatives. With only three total trades executed, the statistical sample size is insufficient to draw any reliable conclusions about the strategy's robustness or alpha generation. The sharp 11.32% drawdown suggests high volatility exposure that was not adequately hedged during these limited market conditions. Given the low trade frequency and poor risk-adjusted returns, the primary issue likely stems from poor parameter fit rather than systemic flaws in the logic. The immediate next step is to expand the backtest to a longer historical dataset to determine if the
