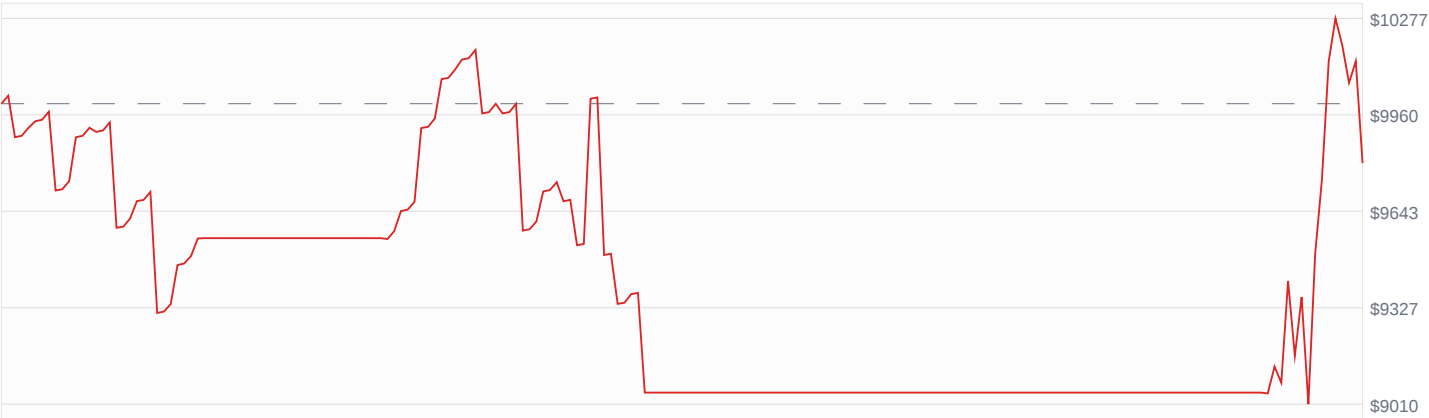

ANALYST NOTE

Hera local LLM

The backtest for VOXR with the EVO_EVOEVOEVOG_v481 strategy shows a negative ROI of minus 2.01 percent and a Sharpe ratio of negative 0.05, indicating the approach failed to generate risk-adjusted returns. With only three trades executed, the win rate of 33.3 percent is statistically insignificant and the maximum drawdown of 11.32 percent cannot be trusted as a true measure of risk. The sample size is far too small to draw any reliable conclusions about the strategy's viability on this asset. A next step would be to run a longer historical simulation or adjust entry filters to increase trade frequency before deploying live capital.
