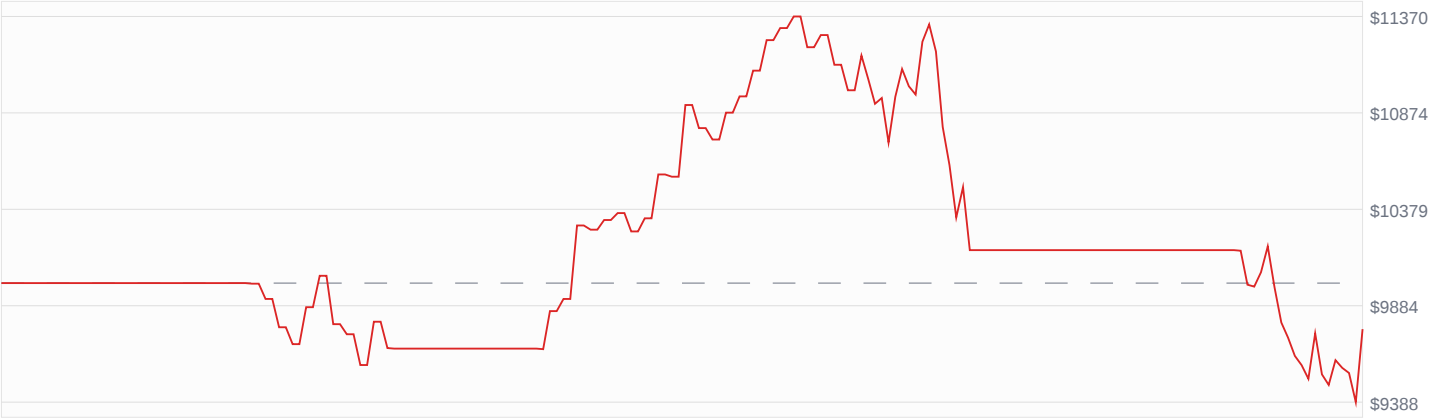

ANALYST NOTE

Hera local LLM

The backtest for AMZN reveals a non-viable strategy with a negative Sharpe ratio of -0.12 and a catastrophic 33.3% win rate across only three trades. Such a sparse sample size renders the statistical significance negligible, making the observed losses likely due to random noise rather than systematic flaws. The maximum drawdown of 17.43% underscores severe capital inefficiency that no institutional portfolio could sustain. Immediate next step involves increasing the simulation window to generate sufficient trade frequency for meaningful parameter optimization.
