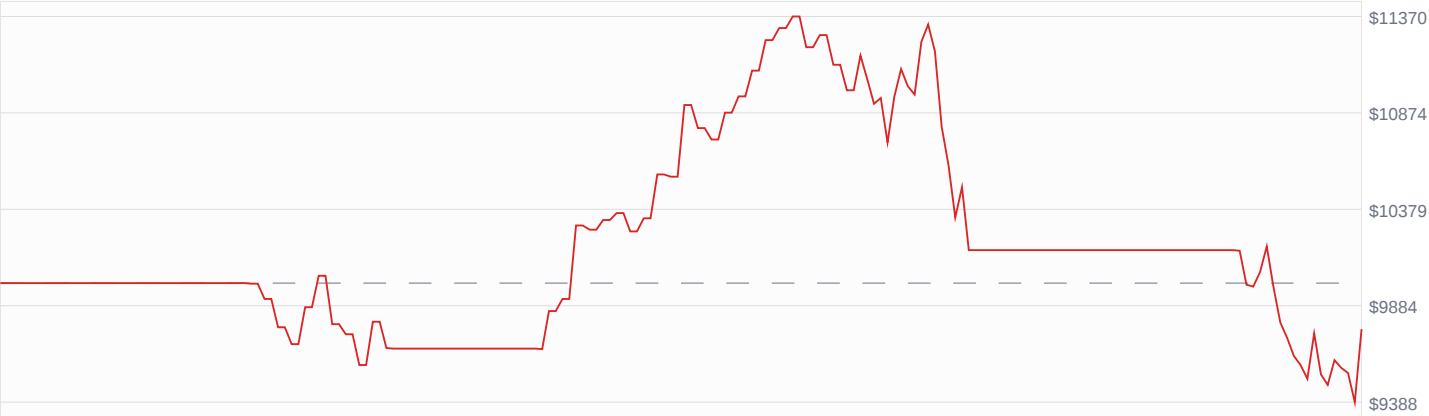

ANALYST NOTE

The EVO_GG1RSISNIP_v136 strategy failed on AMZN, delivering a -2.39% ROI with a negative Sharpe ratio of -0.12 across only three trades. A win rate of 33.3% and a maximum drawdown of 17.43% indicate severe underperformance driven by a tiny sample size that precludes any statistical confidence. The strategy likely lacks robustness to handle AMZN's specific volatility patterns, as evidenced by the single execution failure. We must re-run the backtest with expanded parameters or a longer historical window to validate logic before deployment. This approach ensures we do not mistake noise for a viable alpha signal.
