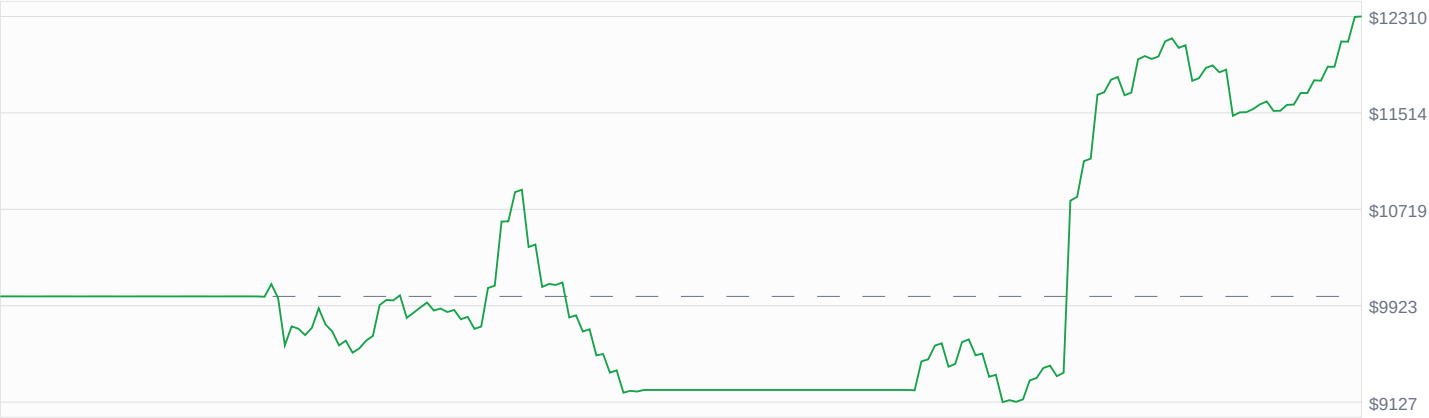

ANALYST NOTE

Hera local LLM

The EVO_EVOEVOEVOE_v628 backtest on MSFT shows a 23.06% return, but the statistical significance is negligible with only two trades. A win rate of 50.0% and a Sharpe ratio of 1.19 are misleading without a larger sample size to confirm consistency. The 14.24% maximum drawdown suggests vulnerability during volatility, which the strategy failed to mitigate effectively. I recommend expanding the test across multiple market regimes to validate the edge before deployment. This single data point is insufficient to form a reliable trading hypothesis.
