Hera local LLM

The EVO_EVOEVOE_v639 strategy on META failed catastrophically, posting a negative ROI of 17.50% with zero winning trades. A sample size of only three trades renders the statistical output meaningless and precludes any reliable confidence intervals. The strategy lost 33.28% of capital with a negative Sharpe ratio, indicating severe underperformance relative to risk. We must immediately halt execution and re-evaluate the signal logic rather than optimizing parameters. The next step is to run a new backtest on a longer historical dataset to validate any potential edge.
