Hera local LLM

The EVO_EVOEVOEVOE_v727 backtest on PLMR shows a meager +0.43% ROI with a 50.0% win rate, rendering the strategy statistically inconclusive due to only two trades. A maximum drawdown of 14.67% paired with a Sharpe ratio of 0.14 indicates that the strategy lacks the risk-adjusted efficiency required for institutional deployment. We must expand the sample size to validate whether this underperformance is an anomaly or a systemic flaw in the signal logic. Next, we should run a walk-forward analysis across multiple market regimes to assess the robustness of these parameters. Until statistical significance is achieved, the strategy remains unfit for live capital allocation.
