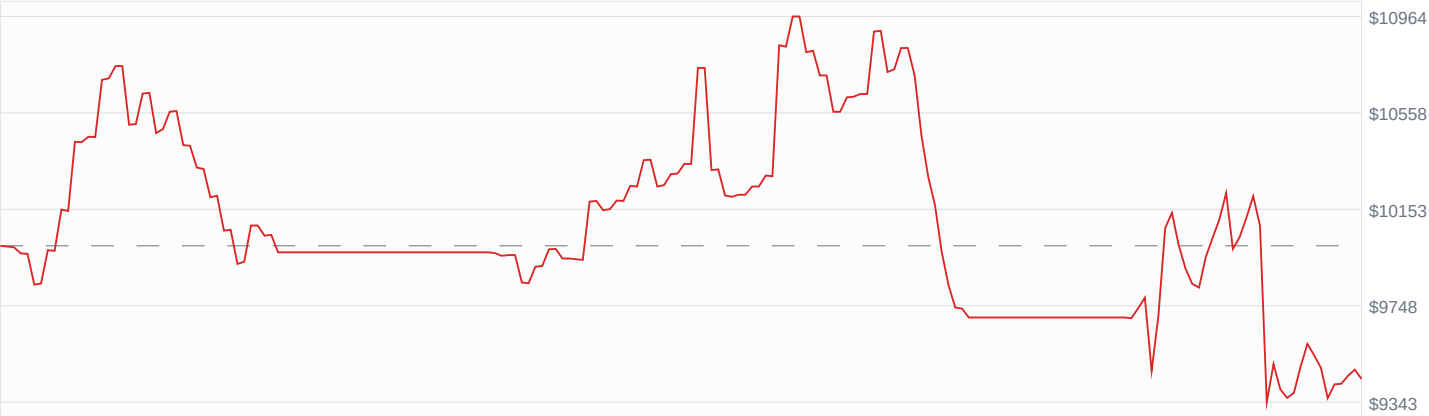

The EVO_EVOEVOEVOG_v1676 backtest on RDN shows a catastrophic failure with zero winning trades and a negative Sharpe ratio, indicating a strategy that consistently lost capital. With only three total trades, the statistical sample is too small to draw any meaningful conclusions about strategy robustness or market adaptation. The maximum drawdown of 14.78% suggests significant exposure risk that was not mitigated by the entry logic during this specific simulation period. Immediate action requires a complete parameter re-optimization or strategy abandonment to avoid further capital erosion.
