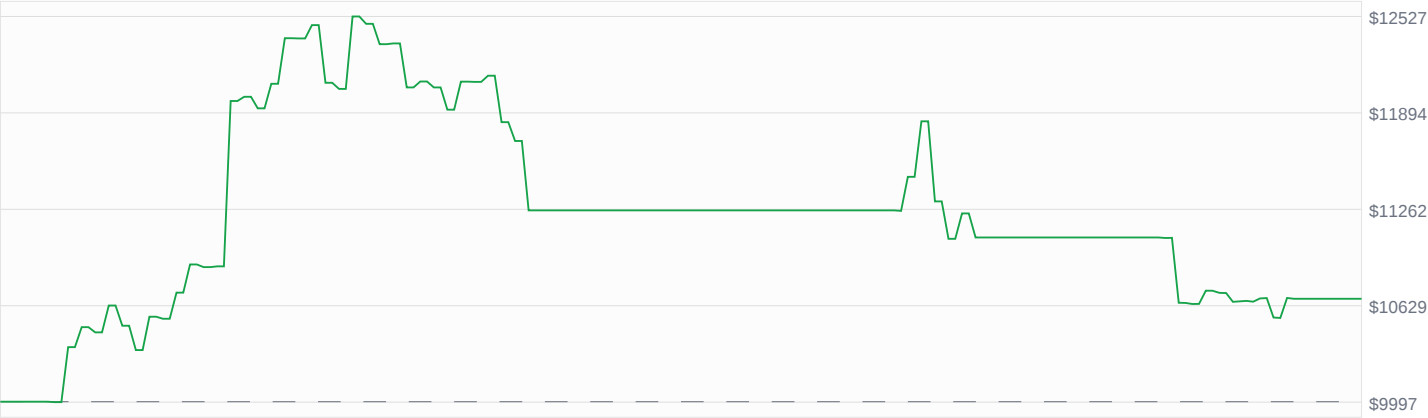

ANALYST NOTE

The EVO_WEBIDEA_v943 strategy on GOOGL generated a modest 6.75% return but suffered from severe undercapitalization with only three executed trades, rendering the Sharpe ratio of 0.54 and win rate of 33.3% statistically insignificant. A maximum drawdown of 15.79% suggests high volatility risk when positions are held, indicating the entry logic fails to capture sustained trends effectively. Given the minimal sample size, these metrics are unreliable proxies for live performance and do not confirm any edge. The immediate next step is to backtest the strategy over a longer historical period with higher frequency entries to validate the robustness of the signal generation.
