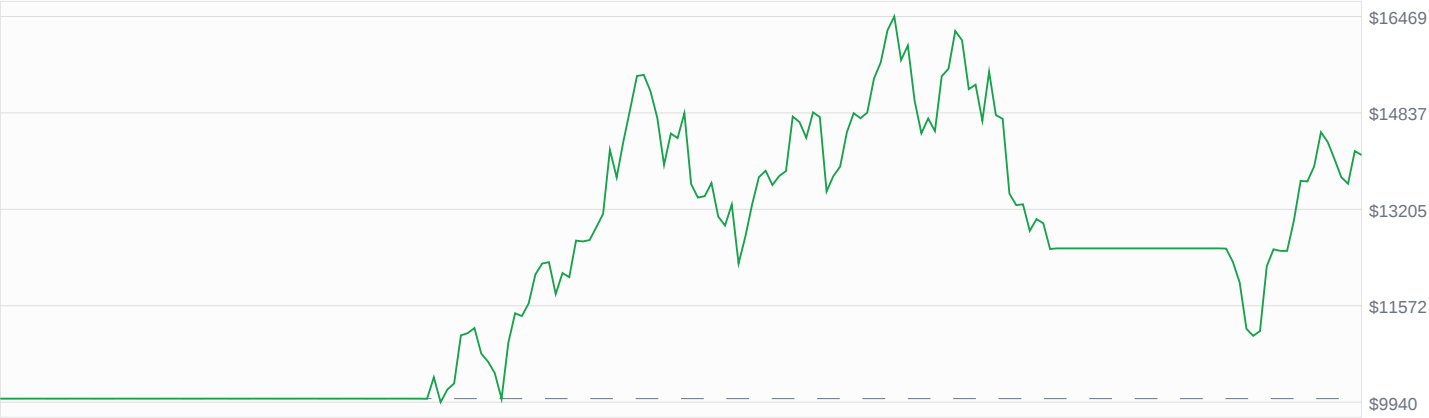

Hera local LLM

The EVO_EVOEVOEVOE_v2307 backtest on SM shows a perfect 100% win rate, but only two trades make the results statistically insignificant and prone to overfitting. A 32.83% drawdown despite flawless wins suggests poor position sizing or aggressive stops that were rarely, if ever, tested. The 1.21 Sharpe ratio indicates marginal risk-adjusted returns for the high volatility inherent in a small sample. You must expand the test window or reduce trade count to validate if this performance is replicable or an outlier.
