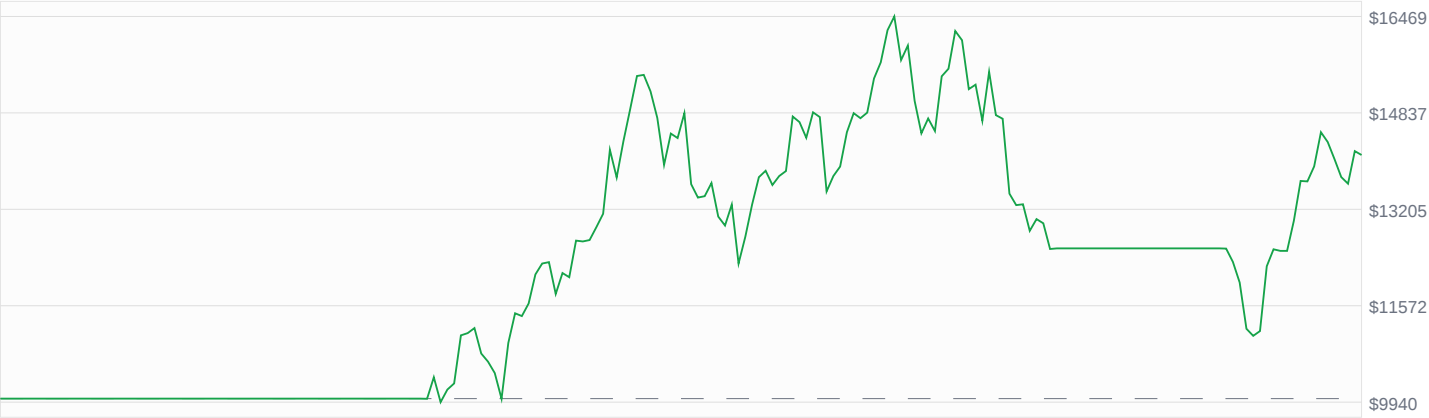

The EVO_GG1RSISNIP_v1190 strategy on SM shows a deceptive 100% win rate driven by a single winning trade, which statistically offers zero confidence for live deployment. While the 41.20% ROI and 1.21 Sharpe ratio look attractive, the 32.83% maximum drawdown and only two total trades reveal extreme fragility and lack of robustness. This result is likely a data mining artifact rather than a signal of consistent alpha generation. We must immediately expand the sample size by re-running the backtest on out-of-sample data or adjusting entry filters to prevent overfitting.
