The EVO_GG1RSISNIP_v209 strategy on MSFT generated a 23.06% return, yet statistical significance is impossible with only two trades. A 50% win rate and 1.19 Sharpe ratio are meaningless without volume, as the 14.24% drawdown lacks context for risk management. The sample size creates excessive noise, making any performance attribution to the strategy itself highly unreliable. We must increase the backtest horizon or reduce position sizing to validate edge before live deployment.
