The EVO_GG1RSISNIP_v1262 strategy on SM shows a +41.20% ROI and a perfect 100.0% win rate, but these metrics are statistically insignificant given only two total trades. Such a small sample size invalidates any claim of robustness, as the 32.83% maximum drawdown indicates high volatility that could easily reverse with just one loss. The 1.21 Sharpe ratio suggests decent risk-adjusted returns on paper, yet the lack of trade frequency prevents reliable performance attribution. To validate the strategy's viability, we must execute a backtest with significantly increased trade frequency or longer historical data before deployment.
