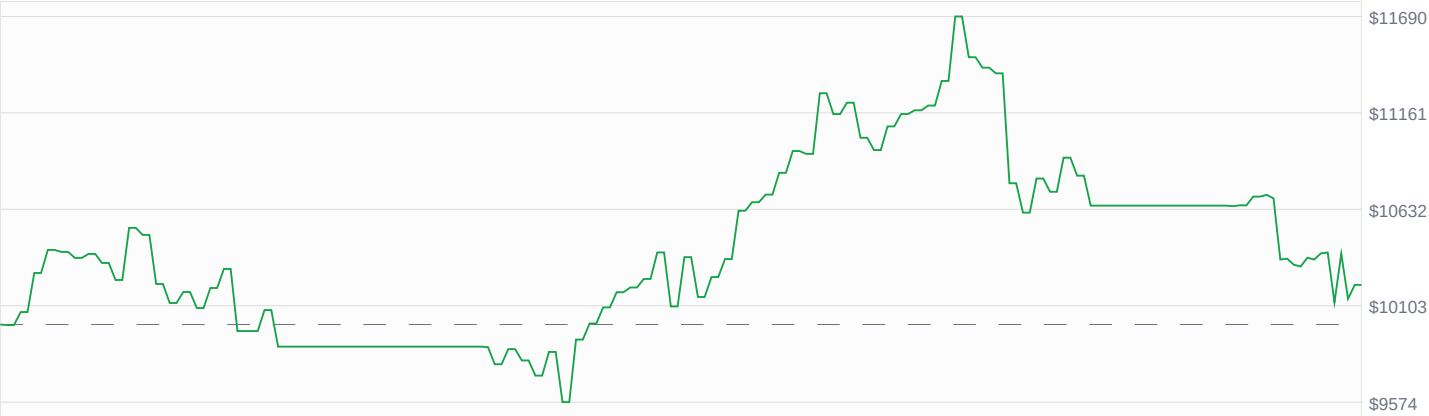

ANALYST NOTE

Hera local LLM

The EVO_EVOEVOEVOE_v1946 strategy on BWB generated a meager 2.15% return with a statistically insignificant sample size of only three trades, rendering the 33.3% win rate and 0.25 Sharpe ratio unreliable indicators. The 13.41% maximum drawdown exposes a severe vulnerability to adverse market moves that the current logic failed to mitigate effectively. Given the insufficient trade count, any performance metrics are subject to extreme variance and cannot support a robust conclusion on strategy viability. The immediate next step is to expand the historical lookback period or adjust entry filters to generate a larger sample set for meaningful statistical validation.
