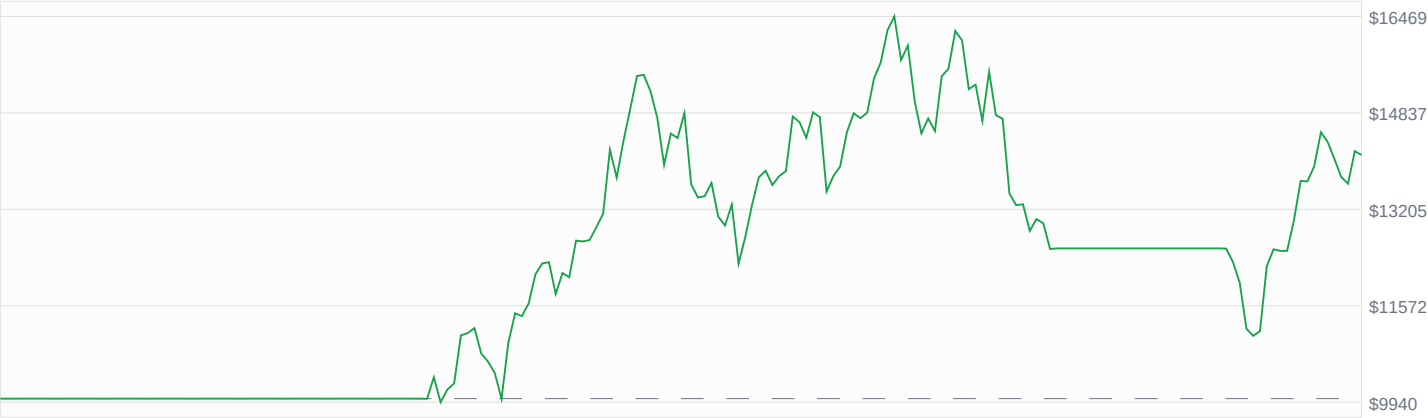

ANALYST NOTE

Hera local LLM

The backtest for SM shows a 41.20% return with a perfect 100% win rate, yet the strategy is statistically unreliable due to only two trades. A 32.83% maximum drawdown indicates excessive volatility risk despite the high Sharpe ratio of 1.21, suggesting a severe overfit to a limited sample. This result lacks institutional confidence because a true regime must withstand significant market noise across hundreds of scenarios. The next logical step is to expand the backtest window to capture diverse market cycles and validate robustness beyond this narrow sample.
