The EVO_EVOEVOEVOE_v1966 strategy shows a 18.35% return on ASC, yet the 17.18% drawdown and mere 3 trades suggest insufficient statistical confidence for live deployment. While the 66.7% win rate indicates positive expectancy, a Sharpe ratio of 0.82 implies suboptimal risk-adjusted performance relative to market volatility. The limited sample size renders these metrics highly susceptible to regime-specific noise rather than robust alpha. The next step is running a stress test across 2024-2025 data to validate drawdown resilience before any capital allocation.
