The backtest for RDN reveals a catastrophic failure where the strategy generated zero winning trades and a negative Sharpe ratio of -0.31. With only three executed trades, the statistical sample is too small to draw any reliable conclusions about the strategy's viability. The maximum drawdown of 14.78% indicates that the risk management logic failed to preserve capital under current market conditions. Adjusting entry filters to avoid low-volatility environments or reducing position size is the necessary next step. This approach is purely educational and not investment advice.
