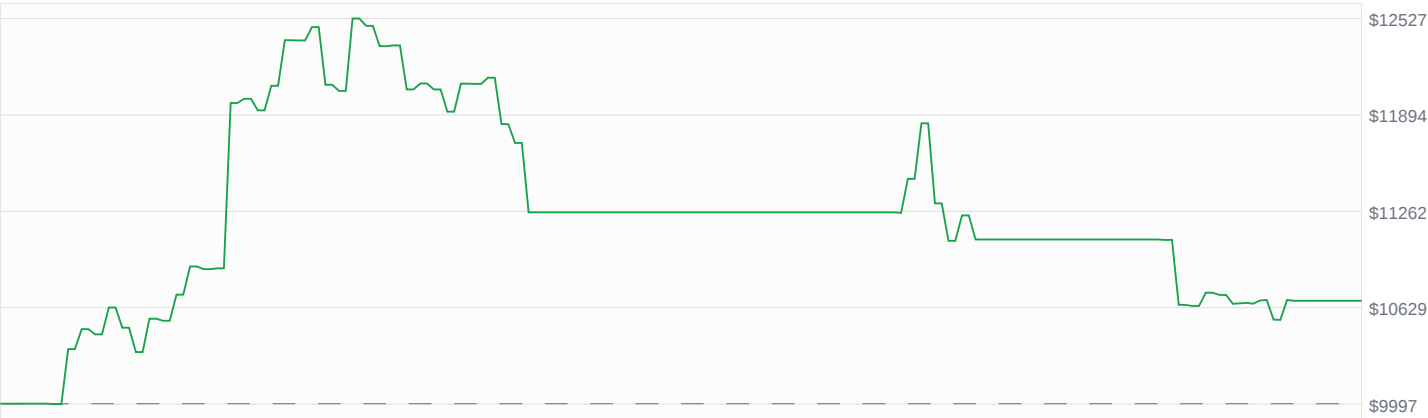

ANALYST NOTE

The EVO_EVOEVOE_v2077 strategy on GOOGL generated a modest 6.75% gain, yet the 33.3% win rate and 15.79% maximum drawdown reveal a high-risk profile with a weak Sharpe ratio of 0.54. With only three executed trades, the statistical sample is too small to confirm any genuine alpha, rendering the performance unreliable. The strategy likely suffered from overfitting or excessive noise sensitivity rather than capturing a consistent trend. We must expand the backtest horizon to 2015 and increase trade frequency to validate robustness before deployment.
