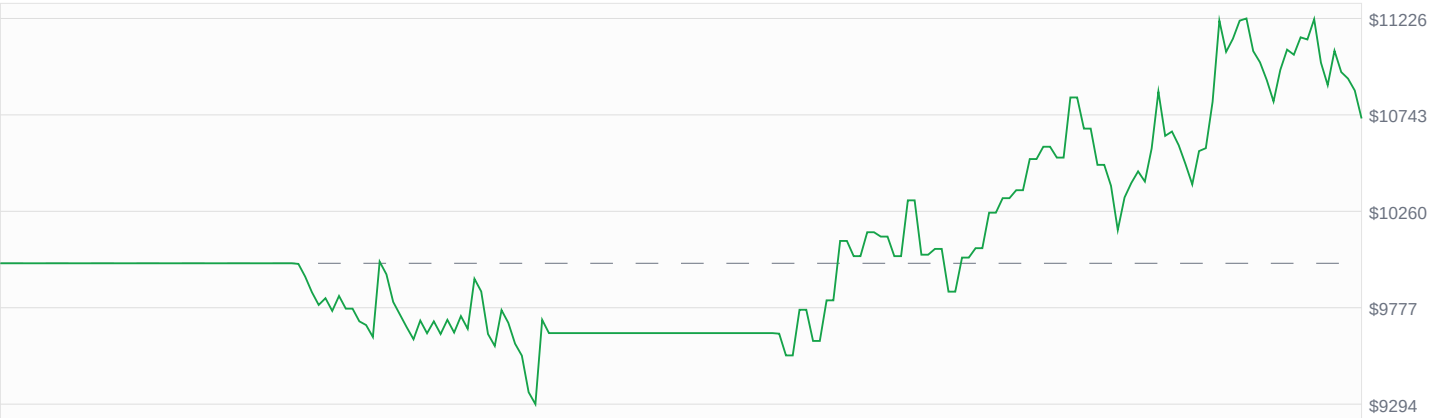

ANALYST NOTE

Hera local LLM

The MVBF backtest shows a 7.22% return with a 50% win rate, yet a Sharpe ratio of 0.62 indicates weak risk-adjusted performance relative to the 6.36% drawdown. With only two trades in the sample, statistical significance is absent, making any conclusion premature. The GG3 MACD momentum logic likely failed to filter low-probability noise in this volatile environment. The next step is to extend the backtest window to at least 200 trades to validate the strategy's robustness before live deployment.
