The EVO_EVOEVOEVOE_v1987 strategy on VOXR failed with a -2.01% return, driven by an abysmal 33.3% win rate and a maximum drawdown of 11.32%. With only three trades executed, the negative Sharpe ratio of -0.05 lacks statistical significance, rendering any performance metrics unreliable noise rather than signal. The sample size is too small to confirm a systematic flaw, yet the loss of capital suggests the entry logic requires immediate recalibration. You must increase trade frequency by tightening filters or widening stop-losses to generate a robust dataset before re-evaluating viability.
