ANALYST NOTE

Hera local LLM

The EVO strategy generated a 36.29% ROI with a 66.7% win rate, yet the statistical significance is critically low given only three trades. A 21.82% maximum drawdown indicates high volatility and substantial risk exposure that the current sample size fails to validate. While the 1.04 Sharpe ratio suggests favorable risk-adjusted returns, the lack of trade diversity prevents confident extrapolation to live markets. We must expand the test dataset or adjust entry filters to reduce false positives before deploying capital.
