The EVO_GG1RSISNIP_v230 strategy on RDN failed catastrophically, posting negative returns with a zero win rate across only three trades. A Sharpe ratio of -0.31 and a 14.78% drawdown indicate severe underperformance relative to risk, likely due to overfitting or a regime shift. With such a tiny sample size, statistical significance is nonexistent, rendering these metrics unreliable for live deployment. Immediate action requires parameter optimization or strategy redesign before any further capital allocation.
