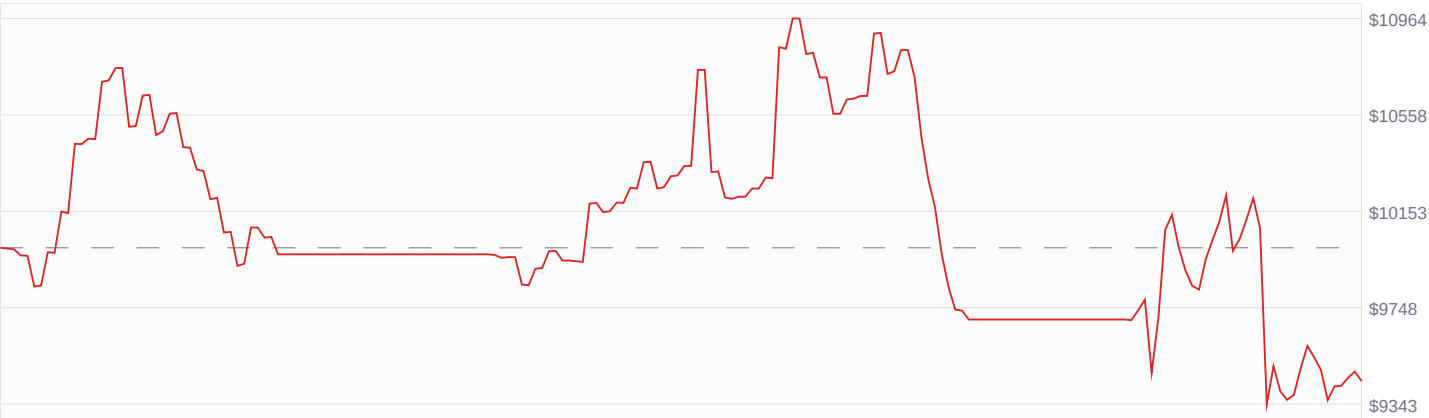

ANALYST NOTE

The RDN backtest for EVO_EVOEVOE_v648 failed catastrophically with a zero percent win rate and negative Sharpe ratio, indicating the strategy is statistically non-viable on this sample. With only three trades executed, the results lack the statistical power to draw reliable conclusions, and the 14.78% maximum drawdown suggests excessive risk exposure during the limited period. The strategy clearly requires parameter optimization or a complete rule revision before any live deployment is considered viable. Immediate recalibration of entry signals is necessary to address the total lack of profitable positions in this short simulation.
