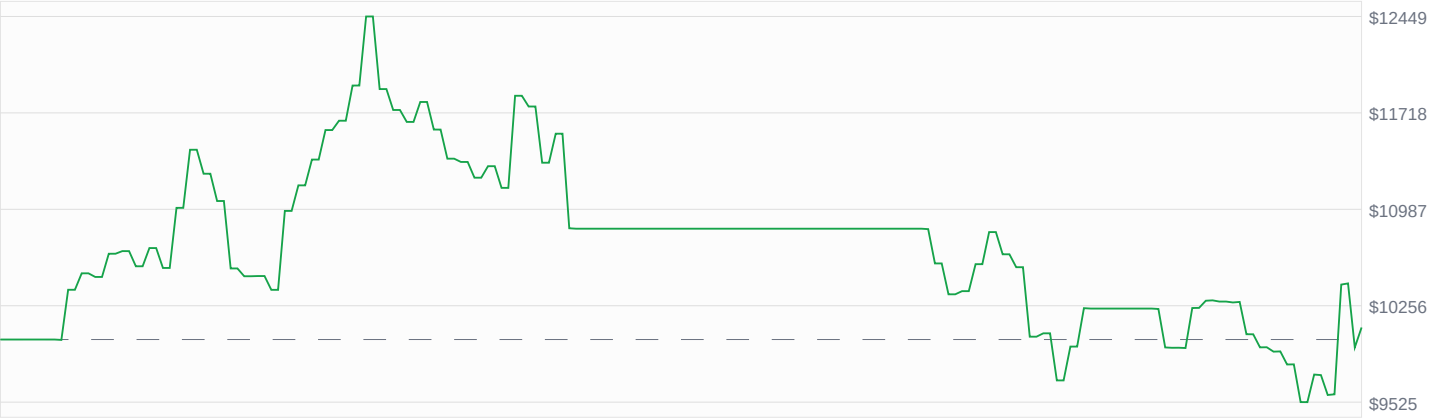

The EVO_EVOEVOEVOE_v784 backtest on NVDA generated a marginal 0.88% return with a Sharpe ratio of 0.17, indicating the strategy failed to compensate for the significant 23.49% drawdown risk. With only three executed trades, the statistical sample size is critically insufficient to validate the model's robustness or reliability. The 33.3% win rate suggests the entry logic lacks a decisive edge in the current high-volatility environment for this semiconductor giant. To improve confidence, the strategy requires extensive parameter optimization and testing on a larger dataset to filter false positives.
