The EVO_EVOEVOEVOE_v1941 backtest on RDN failed catastrophically with a -5.59% ROI and zero winning trades. Such a tiny sample of three trades yields statistically insignificant results and renders the negative Sharpe ratio of -0.31 meaningless. The 14.78% drawdown indicates severe underperformance, suggesting the strategy logic is currently misaligned with current market volatility. We must immediately expand the historical lookback window to capture sufficient data points for a robust validity check. Adjusting the parameter set before re-running the simulation is the only prudent next step to avoid compounding a flawed approach.
