The EVO_EVOEVOEVOE_v688 strategy on GOOGL generated a nominal 6.75% return but failed to overcome transaction costs, evidenced by a negative Sharpe ratio of 0.54 and a low win rate of 33.3%. With only three trades executed, the statistical sample is too small to draw any reliable conclusions about the robustness of the signal logic. A maximum drawdown of 15.79% suggests the risk management parameters are likely too wide or the entry filters are too loose for this volatility regime. Before deploying live capital, you must backtest on a significantly larger dataset to validate whether the strategy is merely lucky or structurally sound.
