ANALYST NOTE

Hera local LLM

The negative ROI of -2.01% and Sharpe ratio of -0.05 indicate the strategy failed to generate risk-adjusted returns for VOXR. A 33.3% win rate combined with an 11.32% max drawdown suggests poor reward-to-risk dynamics in recent executions. Statistical confidence is virtually nonexistent due to the tiny sample of only three trades, making performance metrics highly unreliable. The next concrete step is to expand the backtest period to at least one hundred trades to establish a valid baseline before any further optimization.
