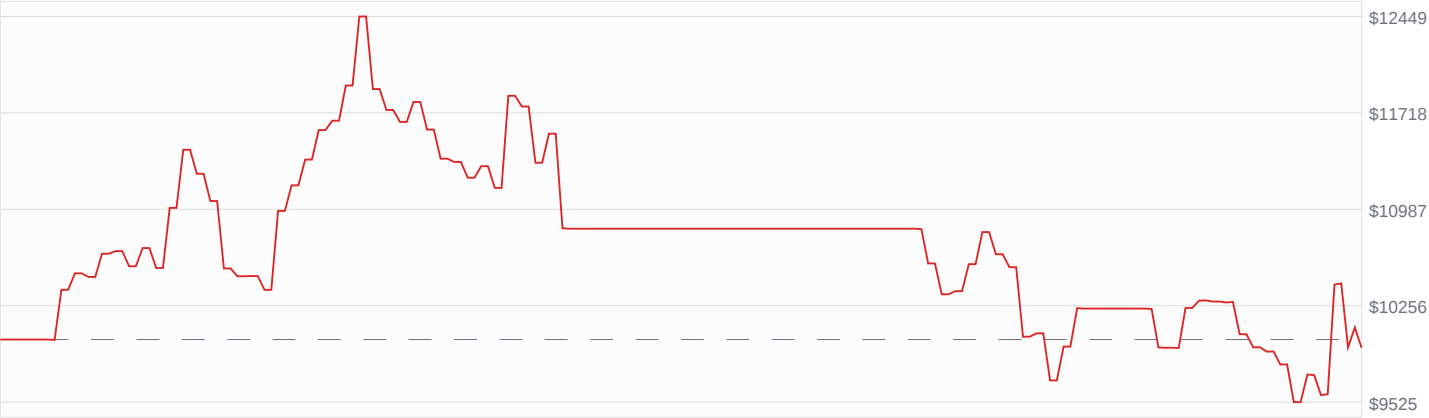

ANALYST NOTE

Hera local LLM

The EVO_GG1RSISNIP_v974 backtest on NVDA reveals a critical failure with a negative ROI of -0.66% and a dangerously low win rate of 33.3%. Statistical confidence is virtually nonexistent given only three total trades, rendering the Sharpe ratio of 0.09 and the 23.49% maximum drawdown meaningless. The strategy lacks robustness against market volatility and fails to generate consistent alpha under current conditions. Immediate action requires expanding the sample size through a longer backtest window or adjusting entry filters before deployment.
