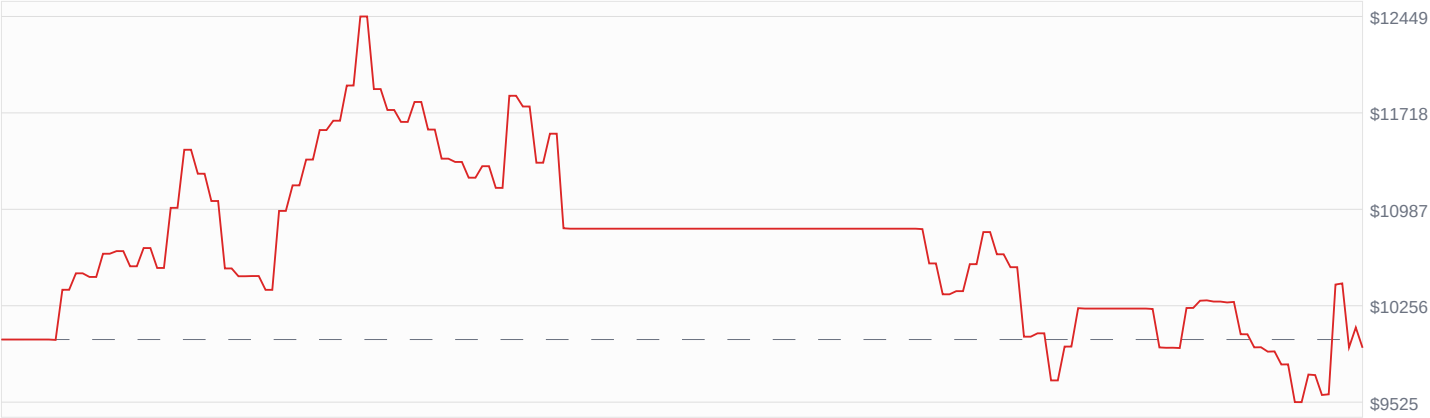

ANALYST NOTE

The EVO_GG1RSISNIP_v1053 strategy on NVDA failed decisively, generating a negative return of 0.66% with a meager Sharpe ratio of 0.09. The sample size of only three trades is statistically insignificant, making the 33.3% win rate and 23.49% drawdown unreliable indicators of true strategy performance. This poor outcome likely stems from an inability to adapt to recent volatility or a flawed entry logic that triggers too frequently in noise. Before deploying any capital, you must expand the backtest window to capture more market regimes and re-optimize the parameters.
