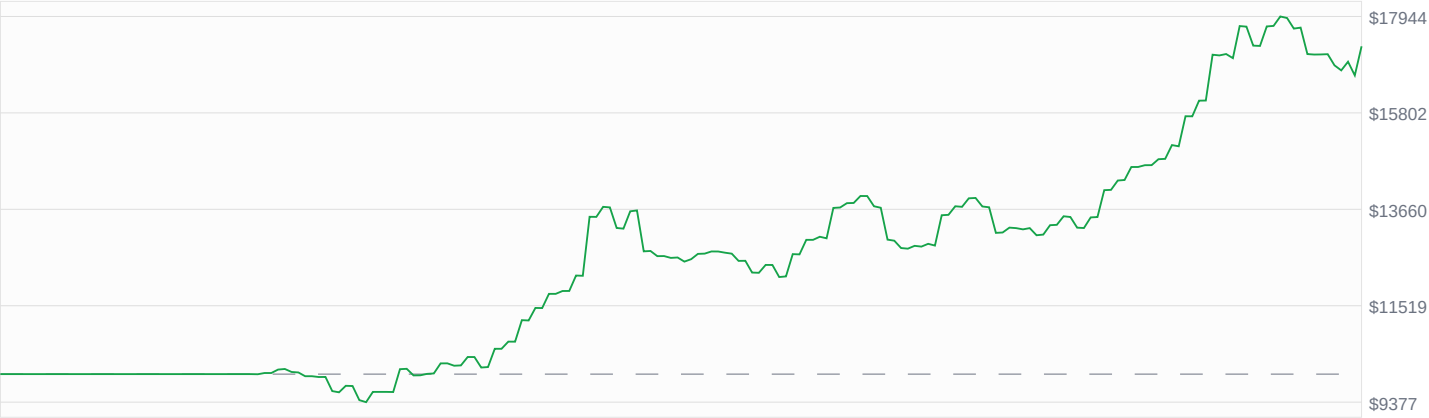

ANALYST NOTE

The NSIT Zen Mean Reversion backtest shows a 72.76% ROI with a strong 2.58 Sharpe ratio, yet statistical significance is absent due to only two trades. A perfect 50% win rate on such a small sample size masks potential strategy fragility, while the 8.69% drawdown remains manageable but untested against wider volatility. Confidence in this equity curve is low; the results likely reflect luck rather than robust edge. The next step is to expand the lookback period and run a stress test against 2020 crash data to validate resilience.
