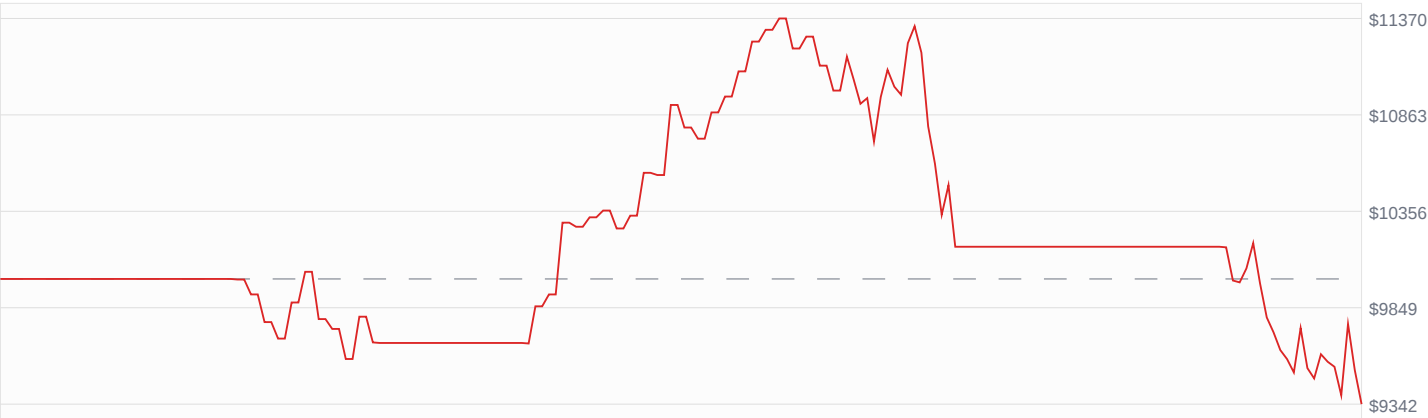

ANALYST NOTE

Hera local LLM

The AMZN backtest for EVO_GG1RSISNIP_v1175 failed due to low trade frequency and negative risk-adjusted returns, yielding a -6.61% ROI and -0.47 Sharpe. With only three executed trades, statistical significance is nonexistent, making the 33.3% win rate and 17.84% drawdown statistically unreliable. The strategy likely suffered from overfitting to a specific short-term price regime or an overly strict entry filter that prevented position establishment. Next, broaden the sample by running a longer historical backtest with a 10% larger capital base to assess consistency and reduce noise.
