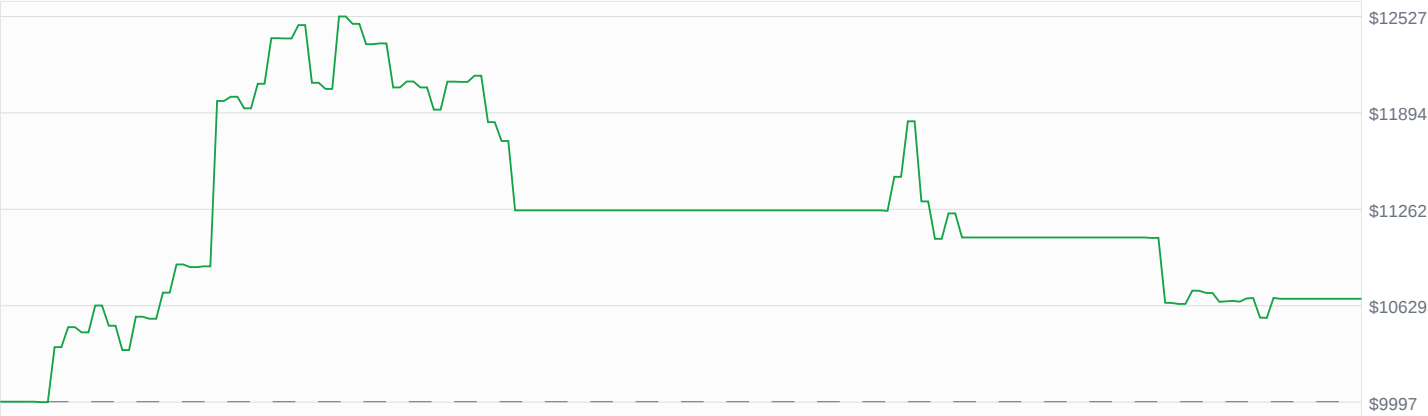

ANALYST NOTE

Hera local LLM

The EVO_EVOEVOE_v1899 strategy on GOOGL generated a +6.75% ROI with a 33.3% win rate, yet the statistical significance is negligible given only three trades. A 15.79% maximum drawdown coupled with a low 0.54 Sharpe ratio indicates high volatility relative to returns, suggesting the approach lacks robust risk-adjusted performance. The sample size is insufficient to validate the strategy's edge, making the observed gains likely noise rather than a repeatable alpha. Next, expand the backtest to include multiple market regimes or reduce the trade frequency to increase the dataset for a reliable confidence interval.
