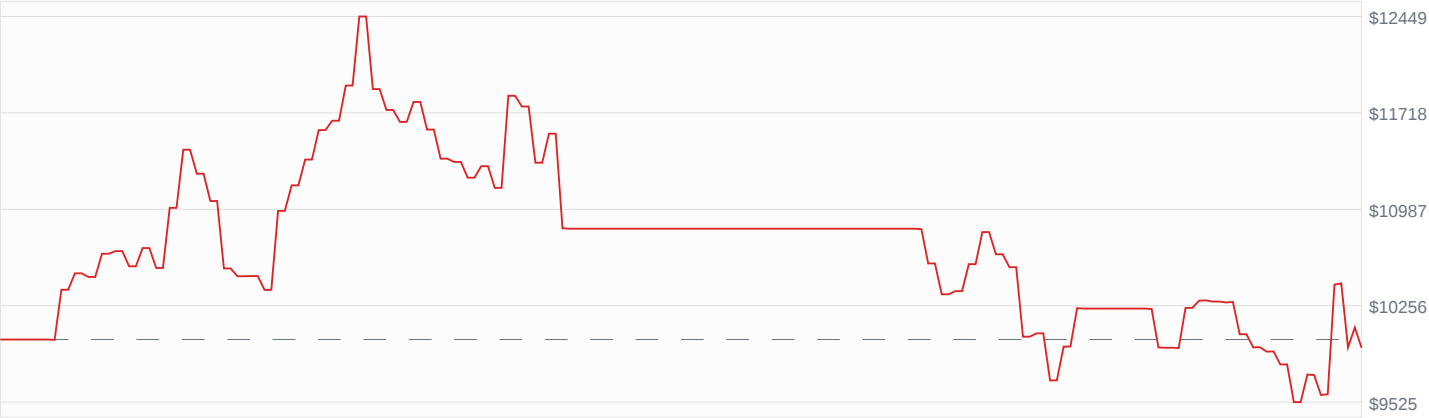

The EVO_EVOEVOEVOE_v2083 strategy failed decisively on NVDA, generating a negative return and exhibiting a dangerously low win rate of 33.3%. With only three trades executed, the Sharpe ratio of 0.09 and 23.49% drawdown indicate severe instability rather than a robust market inefficiency. Statistical significance is impossible to establish with such a minimal sample size, rendering any performance metrics unreliable. We must expand the testing horizon across multiple market regimes before deploying any logic derived from this simulation. Re-running the backtest with stricter entry filters or different asset classes is the immediate next step.
