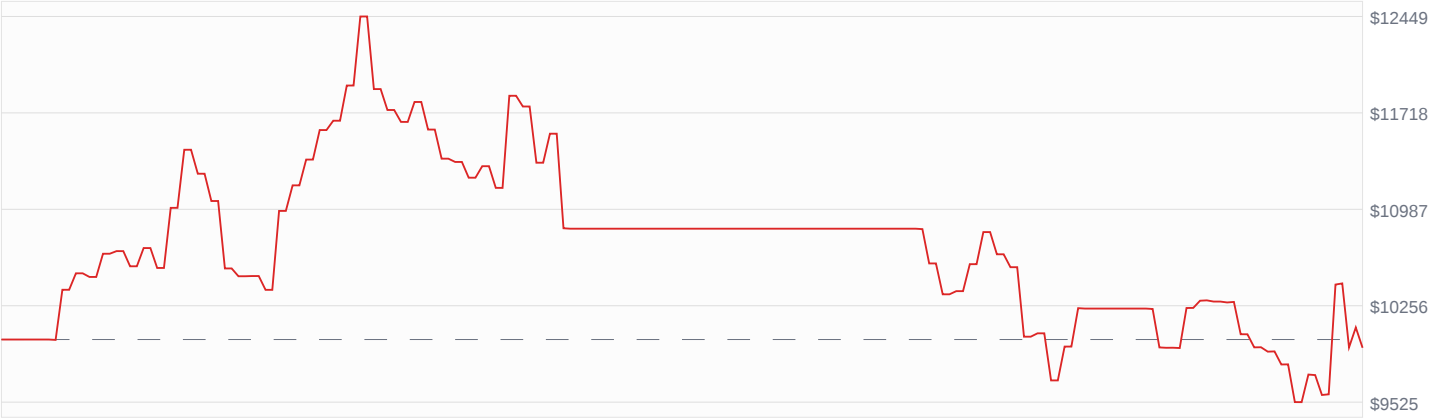

ANALYST NOTE

Hera local LLM

The EVO_WEBIDEA_v1734 strategy on NVDA failed to generate positive returns with a -0.66% ROI and a negligible 0.09 Sharpe ratio. Such a low win rate of 33.3% and a severe 23.49% max drawdown indicate a lack of edge given only three total trades. These metrics are statistically insignificant, meaning the results could easily be noise rather than a reflection of true market inefficiency. The limited sample size prevents any reliable assessment of the strategy's long-term viability or risk profile. Before adjusting parameters, the team must test the logic against a larger historical dataset to validate the signal generation.
