The EVO_EVOEVOEVOE_v190707 strategy on NVDA delivered a marginal -0.66% ROI with a dismal 33.3% win rate and a 23.49% maximum drawdown, indicating severe underperformance relative to capital preservation goals. With only three executed trades, the statistical sample is too small to derive any meaningful Sharpe ratio of 0.09 or validate the strategy's robustness, rendering the negative returns statistically insignificant rather than definitive proof of failure. The extreme drawdown suggests the entry logic generated premature exits during high volatility, while the low trade count implies the signal generator failed to identify sufficient opportunities in the current market regime. The immediate priority is to expand the backtest
